Final Group Project

- Form a group of 3 5 people consisting of students teaming up in the groups in Canvas. No later than **February 10th**. With assessment at the end of semester for each team member (5 points)
- The group decides on the data set of interest, posing research questions and applying multivariate analysis techniques to address those questions. This proposal of project needs to be submitted by March 22nd. (10 points)
- A rough draft to show progress on your project is due on April 5th. (10 points)
- Each group will eventually submit a report of research findings, with some groups getting a chance (or required) to present their findings in class. Due date for final project **April 29th**. (50 points)
- Extra Credit: Each group will have an opportunity to present their project the last week of class, April 26th. More details to come.
